

The "242 Short Film Festival - 4th edition" is produced by ICS Company Ass. Cult. and Slup Tv S.r.l. together with: **CinecittàLuce – Maremetraggio – Scuola di Cinema di Roma**

Time frame: the festival will take place in December 2010 at the "Casa del Cinema" in Villa Borghese, Rome, Italy. It will include public screenings and Workshops. The on-line section of the contest will take place in October and November 2010 on www.242movietv.com. The Award Ceremony for both sections will be held on December 5 during the closing evening of the festival.

"242 Short Film Festival" Section: This section is open to all International Directors. Short film length should be less than 30 minutes. The works will be screened to a public audience and judged by an artistic jury nominated by ICS Company and Slup Tv s.r.l.

"No boundaries" Section: it's a non compulsory on-line section of the festival. All works submitted to the "242 Short Film Festival" may take part under to the on-line competition after the director has granted his/her permission to upload the video on the web site. The **1.000€ Prize** will be awarded by the 242movietv.com on-line community (i.e. by all its purposely registered users), through a web-based poll.

Awards: The artistic Jury award consists of a **5.000€ first prize** and the participation to the "Maremetraggio Film Festival"; The Community award consists of a **1.000€ first prize**; the **Emerging Talent Award** consists of a grant to attend an Avid Certified Course to be held at the Scuola del Cinema di Roma.

Terms of participation: **Taking part in the 242 Short Film Festival DOES NOT entail the participation to the on-line section of the competition.**

Directors and producers interested in submitting their works should **register to 242movietv.com beforehand (registration and all services are, and will always remain, totally free)**. After registering they will be allowed to send in their films, on a DVD (single film, no menu, no chapters) **by September 30, 2010** (post service stamp) to the following address: **242 Short Film Festival - 4th Edition c/o Slup Tv - ICS Company - 242 MovieTv - Via Tirone,11 - 00146 Roma.**

All films submitted after September 30, 2010 **WILL NOT enter the contest**. Also, we will not consider as participating in the contest those works submitted with an incomplete form, or without one of the required items hereafter described, and **films submitted by directors or producers NOT REGISTERED or IMPROPERLY REGISTERED to the 242movietv.com web-site.**

Regulations:

The contest is open to Short Films of all kinds and genre, no more than 30 minutes in length, directed by Italian or foreign directors **NOT EARLIER THAN January 2008**. Short Films produced or directed by members of ICS Company and Slup Tv s.r.l. are not allowed to participate. Short Films submitted for earlier editions of the contest will not be considered. The Short Films selected by an artistic committee nominated by ICS Company and Slup Tv s.r.l., will be screened at the "Casa del Cinema" in Rome, Italy, in December 2010. The Short Films whose authorization to be part of the on-line contest has been filled, will be published on 242movietv.com starting October 2010 and will be subject to registered users' evaluation and poll. This will result in the recognition of a 1.000€ prize to the film that has received more votes by November 30, 2010. The Artistic Jury's choice will be communicated during the closing evening of the Festival (December 5, 2010) and the winner will receive a 5.000€ check (five thousand euro). The winning short film will also take part in the 2011 edition of Maremetraggio (unless it has already been selected in one of the previous editions of the same festival).
